PURPOSE:	The purpose of this meeting is to: 1) inform external stakeholders of the recent Commission proposed initiative to improve nuclear safety and regulatory efficiency by applying probabilistic risk assessments (PRAs) to determine the risk significance of current and emerging reactor issues in an integrated manner and on a plant-specific basis; 2) describe the NRC staff's current thoughts on ways to address the proposed initiative; and 3) obtain feedback that will inform the NRC's efforts to address the proposed initiative.

The Commission has directed¹ the NRC staff to develop a notation vote paper that provides approaches for allowing licensees to propose to the NRC a prioritization of the implementation of regulatory actions as an integrated set and in a way that reflects their risk significance on a plant-specific basis. The Commission also stated that such a proposal would require licensees to develop site-specific Level 1 and 2 PRAs, similar to the requirements for new reactors.

The NRC staff is interested in feedback from stakeholders, such as:

- 1) Are licensees interested in the proposed initiative? If so, how many? If not, why not?
- 2) What are the challenges to implementing such an initiative? What are the estimated costs of developing a PRA to meet a requirement similar to new reactors? What are the estimated resources and time to develop guidance to support a prioritization process similar to the maintenance rule or the voluntary risk-informed categorization rule?
- 3) Are there alternatives to the initiative that licensees are interested in piloting that meet the intent of the Commission's proposed initiative?
- 4) What are the appropriate risk metrics for such an initiative?
- 5) What are the appropriate backstops to ensure that issues will be resolved and regulations implemented in a timely matter?
- 6) What is the public's perception of such an initiative?

The NRC staff also encourages the submission of written comments on the matters to be discussed. Those comments may be submitted via http://www.regulations.gov by searching for Docket ID NRC-2013-0064. The opportunity to submit written comments will begin shortly after the public meeting and comments will be accepted until May 28, 2013.

The NRC staff will consider all views and information provided when developing the staff's recommendation to the Commission, but it will not be preparing and making available to the public a detailed response to views and comments presented at the meeting or received in writing.
