ORDER
(Granting Motion for Extension of Time)

On April 4, 2013, Ms. Smith filed a request for a two-week extension of time in which to submit her statement of position, pre-filed testimony, and exhibits.¹ She states that she needs additional time to review and analyze the volume of documentation contained in the hearing file.² She represents that she contacted NRC Staff who does not oppose her motion.³ NRC Staff requests that, if Ms. Smith's motion is granted, its current deadline for filing its statement of position, pre-filed testimony, and exhibits also be extended by two weeks.⁴

For good cause shown,⁵ the Board hereby GRANTS Ms. Smith's motion for an extension of time. Ms. Smith shall file her statement of position, pre-filed testimony, and exhibits no later than Wednesday, May 1, 2013; NRC Staff shall file its statement of position, pre-filed testimony, and exhibits no later than Friday, May 31, 2013; and Ms. Smith shall file her rebuttal testimony within thirty days after her receipt of the NRC Staff's filings.
