# MEMORANDUM AND ORDER (Revised General Schedule)

Under the existing general schedule for this proceeding, the March 21, 2013 issuance of the NRC staff's draft supplemental environmental impact statement (SEIS) triggered the thirty-day period within which Joint Intervenors¹ can timely submit new/amended contentions relative to the draft SEIS, as well as the follow-on fourteen-day period for responses by applicant Strata Energy, Inc., (SEI) and the staff and the seven-day period for any reply by Joint Petitioners. See Licensing Board Memorandum and Order (Revised General Schedule) (Mar. 25, 2013) app. A, at 1 (unpublished) [hereinafter March 2013 Revised General Schedule]. By joint motion dated April 9, 2013, SEI, the staff, and Joint Petitioners have requested a revision of that schedule that would provide Joint Petitioners an additional fourteen days to submit any draft SEIS-related contentions and thereafter extends the filing deadline for SEI/staff responses and Joint Petitioners' reply by twenty-eight days and fourteen days, respectively.

<u>See</u> Joint Motion Requesting Amendment to the Board's General Schedule (Apr. 9, 2013) at 2 [hereinafter Joint Motion]. Also, using as a trigger date the Licensing Board's issuance of a decision on the admissibility of any new/amended contentions, the motion suggests new dates for the submission of mandatory disclosure updates and any dispositive motions and responsive pleadings, although the time frames allotted for these activities generally are consistent with periods provided for in the current general schedule. <u>See id.</u> According to the parties' joint motion, the requested schedule revisions relating to any draft SEIS-associated new/amended contentions are needed "to accommodate the emergence of significant work and family obligations for the parties over the entirety of the schedule . . . taking into account fairness to all parties, holidays, and other obligations." 2 Id. at 1.

Noting that the parties' agreed-upon schedule revisions will not impact the overall time frame within which this proceeding currently is scheduled to be conducted, the Board concludes that under the circumstances presented by the parties, good cause exists for the scheduling extensions being sought. See 10 C.F.R. § 2.307(a). Consequently, the parties' April 9, 2013

joint motion to revise this proceeding's general schedule is granted. Further, a revised version of the general schedule reflecting the new filing dates for the various submissions is included as Appendix A to this issuance.
