Dear Administrative Judges:

In its Order dated March 5, 2009, the Atomic Safety and Licensing Board (“Board”) directed the NRC staff (“Staff”) to tender each month a status report advising as to whether the estimated dates for issuance of the final Safety Evaluation Report (“SER”) (predicted for the late summer of 2009) and the final environmental review document (predicted for December of 2009) have changed.<sup>1</sup> The Staff expects to be able to issue the SER by June 14, 2013. The Staff expects to issue the final environmental review document by the end of August 2013. The Staff notes, however, that there is a possibility of further delay (up to a few months) in issuing the environmental review document due to the complicated nature of the Section 106 consultation activities.

In keeping with the Board’s mandate, the Staff will tender its next monthly status report by May 16, 2013.
