Uranerz Energy Corporation (Uranerz) submitted a letter of intent to the Nuclear Regulatory Commission (NRC) in November 2012 for the amendment of the Jane Dough Unit to the Nichols Ranch ISR Project SUA-1597. The letter stated the amendment was scheduled for submittal in the second quarter of 2013. Because of various regulatory delays, Uranerz is revising the submittal date of the Jane Dough Unit amendment to fourth quarter of 2013.

Details described in the November 2012 notice regarding the Jane Dough Unit remain the same. The Jane Dough Unit will produce uranium by the ISR method and be located in the Pumpkin Buttes Mining District of the Powder River Basin, Wyoming. The project will consist of wellfields with associated header houses that will pump mining solutions via pipelines to the Nichols Ranch Central Processing Plant for processing. The permit boundary for the Jane Dough Unit is directly south and contiguous with the Nichols Ranch Unit. The Jane Dough Unit will cover all or portions of the following areas: Township 43N, Range 76W Sections 20, 21, 27, 28, 29, 30, 31, 32, 33, and 34.
