Additional Synthetic Drug Testing: Petition for Rulemaking Submitted by Mr. Thomas King; Consideration in the Rulemaking Process; 10 CFR Part 26 (PRM-26-8; NRC-2012-0290)

On April 15, 2013, the NRC published a document in the *Federal Register* ([78 FR 22209](#)) informing the public that the NRC will consider the issues raised in PRM-26-8, submitted by Mr. Thomas King (the petitioner), in the rulemaking process. The petitioner requested that the NRC amend its Fitness for Duty program regulations to amend drug testing requirements to test for additional synthetic drugs currently not included in the regulations. The NRC determined that the issues raised in the PRM are appropriate for consideration and will consider them in the ongoing Part 26 of Title 10 of the *Code of Federal Regulations*, Drug and Alcohol Testing; Technical Issues and Editorial Changes rulemaking (RIN 3150-AJ15; Docket ID NRC-2012-0079). The docket for PRM-26-8 is closed.

List of Approved Spent Fuel Storage Casks: HI-STORM 100, Amendment No. 8; Corrections; Final Rule; Correcting Amendments; 10 CFR Part 72 (RIN 3150-AJ05; NRC-2011-0221)

On April 16, 2013, the NRC published a document in the *Federal Register* ([78 FR 22411](#)), correcting amendments to a direct final rule published on February 17, 2012 ([77 FR 9515](#)). The direct final rule amended the NRC's spent fuel storage regulations by revising the Holtec International, Inc. (Holtec) HI-STORM 100 Cask system listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 8 to Certificate of Compliance (CoC) No. 1014. The direct final rule was effective on May 2, 2012 ([77 FR 24585; April 25, 2012](#)). The NRC made non-substantive corrections to the technical specifications and the NRC's Safety Evaluation Report for the Holtec HI-STORM 100 Cask System. This correcting amendment is effective May 16, 2013.

Fermi 2 Measurement Uncertainty Recapture Power Uprate Acceptance

By application dated February 7, 2013, the licensee requested approximately 1.64 percent measurement uncertainty recapture power uprate for Fermi 2 using Cameron CheckPlus Leading Edge Flow Meter ultrasonic flow measurement instrumentation. On March 19, 2013, the staff identified the need for supplemental information and by letter dated April 5, 2013, the licensee provided the supplemental information. By letter dated April 12, 2013, the staff informed the licensee that the application provides technical information in sufficient detail to enable the staff to proceed with its detailed technical review.

Category 2 Meeting on Risk-Informed Regulatory Framework for New Reactors

On April 15, 2013, the staff held a Category 2 meeting to continue discussions with the industry and staff regarding specific aspects of the Commission's Staff Requirements Memorandum to SECY-12-0081, "Risk-Informed Regulatory Framework for New Reactors." Group participants discussed the technical basis for the use of deterministic backstops and the pros and cons for the use of relative risk measures.
