Kathy,

This is a difficult question to answer since the numbers very all the time.

Factors to consider:

- 1. The companies that repair the gauges have cut their staff in half and are taking twice as long to return the parts therefore the average repair time is now 4 weeks.
- 2. Many gauges are in storage and are not being used on a regular basis will need calibration and/or repairs once the government starts to award contracts. When that happens, it will be difficult to predict when the gauges will be delivered.
- 3. I try to have a maximum turn-around-time of 4 days or less, but the companies on the other side of the island usually go to San Juan once every two weeks. So the gauges remain in storage until they are able to pick them up.

If at all possible, I would respectfully request we make an exception for my license to have it stated, "as need" limit. This based on the fact that calibrations and repairs are on an as needed basis. If this is not possible, the following are the numbers that you requested:
