How far from the proposed Fermi 3 discharge is the City of Monroe water intake?
What will be the level of dilution at the Fermi 3 discharge. What type of monitoring will there be for verification purposes?
Will there be a radiation monitor at the Fermi 3 discharge (what is the methodology including proximity of monitor)
Will there be a radiation monitor at the City of Monroe water intake?
The City of Monroe water intake is very close to the Fermi Complex.
What are the patterns of water flow from the point of discharge past the City of Monroe water intake?
Are there other water intakes for municipalities in the vicinity?
What modeling has been used.
