Hello Mr. Nadeau,

I'm writing to confirm arrangements for the Dewey Burdock survey next week. I've copied Brady Grant so he has this information as well.

NRC will be sending you an email with additional information tomorrow but here are some of the essential logistical details for survey participants.

NRC requests that all participants gather at the Powertech office in Edgemont, SD at 8:00AM on Tuesday, April 2nd. NRC has scheduled a brief Kick-Off meeting for the morning of April 2 to coordinate activities and distribute project area maps and other survey area information. Powertech will provide transportation to and from the project area each day departing from their office in Edgemont.

As suggested in the Feb 8 letter, participants should make their own arrangements for lodging in or near Edgemont, SD for the duration of the survey period (April 1-May 1). Powertech will distribute mileage reimbursement and per diem allowance (\$125/day) to participants at the Kick-Off meeting and periodically over the course of the survey period. A
