Dear Colleagues,

As some of you already know, the Control of Sources Network (CSN) (http://gnssn.iaea.org/CSN/default.aspx), which has been developed to provide a platform for regulators for sharing information, knowledge and experience, has been launched in the past year.

The CSN has recently been restructured and updated, and some of its current contents are:

- IAEA documents relevant to control of sources (safety requirements and guides, TECDOCs and guidelines, international instruments, etc.)
- A library for sharing regulatory documents among regulators in Member States
- Calendar of activities (annual planned meetings, workshops, training courses)
- Available training Packages

The sub-site on RAIS contains:

- RAIS documentation
- Calendar relevant to RAIS activities
- Different version of RAIS (RAIS 3.0 RAIS 3.2)
- A blog for discussion among users of RAIS
- · Frequently asked questions
