Dear Dr. Cherry:

On November 6, 2008, the U.S. Army Installation Management Command (IMCOM or the Army) submitted a license application to the U.S. Nuclear Regulatory Commission (NRC) requesting a source material license to allow possession of depleted uranium from the M101 Davy Crockett spotting round on the Army's Hawaiian installations (Agency Document Access and Management System (ADAMS) Accession Number ML090070095). On June 28, 2012, the NRC staff provided the IMCOM staff with a draft license containing license conditions that the NRC staff determined were necessary to ensure that NRC regulations and requirements would be met at the Army's Hawaiian installations (ML12179A321). On September 10, 2012, the Army staff provided comments on the draft license (ML12265A173) and on December 12, 2012, the Army and NRC staffs met to discuss the draft license. A summary for this meeting can be found at ML12354A165 and the Army's comments on the meeting summary can be found at ML13046A176.

The NRC staff has reviewed the documents cited above, and has developed draft resolutions to the conditions contained in the draft license (see Enclosure). We request a meeting with the Army on May 30, 2013, from 2:30 p.m. until 5:30 p.m. at NRC Headquarters in Rockville, Maryland to discuss these draft resolutions. As with the previous meetings between NRC and Army staffs, this meeting will be open to observation by the public and, at the conclusion of our technical discussion, time permitting, the NRC will provide an opportunity for interested individuals to ask NRC staff questions. NRC will provide a call in number for Army staff to participate in the meeting and for interested individuals to observe the meeting and ask NRC staff questions.
