Dear Mr. Cronin,

Thank you for participating in the public meeting on the Cumulative Effects of Regulation; I'm sorry that you were unable to ask your questions during the meeting.

First, the NRC views the CER process as applying to all licensees, including non-power reactor licenses. At this time, the NRC is not planning to hold a public meeting that will focus specifically on the CER impact on non-power reactor facilities(NPRs). However, the NRC encourages NPRs to participate in all future meetings on CER, and is certainly interested in obtaining feedback and understanding the CER concern at NPRs. Along those lines, the NRC staff would encourage NPRs to participate in either of the case studies discussed at the public meeting, if there is interest.

To answer your second question, the division director and deputy division director that oversee the non-power reactor branches were present at the public meeting.

In a separate e-mail, you asked about the regulations.gov docket that will be established for the CER effort. Once that docket is available, I will send the docket number to the distribution list which contains all attendees at today's meeting. The docket number will also be provided in the public meeting summary.
