This is the additional information that you needed to complete the amendment actions pending for this licenses.

1. You can reference IU LaPorte license, 13-15151-01, amendment #44 for James Hatten's RSO experience for 35.100-500. This information should be adequate to complete his appointment on all three licenses as the RSO.
2. James Hatten is available to support these facilities 24 hours/day and 7 days/week. His office associates, 1 CHP and 2 Health Physics Consultants, are also available to assist with any real emergencies. Jim will be at each site at least once per quarter. These visits are currently planned for monthly with visits as needed to each location. Santosh is currently the RSO delegate at all three locations. The RSO duties for James Hatten are expected to be for the remainder of this year.
3. We also request recognition of James Hatten and Jackie Katz as personnel authorized to discuss and sign amendment requests for all three hospitals identified above.
