The Atomic Safety and Licensing Board hereby gives notice that a hearing will be conducted in this proceeding pursuant to the Board's February 19, 2013, Order granting Ms. CharliSSa Smith's demand for hearing. LBP-13-03, 77 NRC \_\_ (2013). This hearing will consider Ms. Smith's arguments related to her allegation that the NRC wrongfully denied her application for a Senior Reactor Operator license.

The hearing will occur on Thursday, July 18, 2013, and will commence at 9:00 a.m. EDT. The hearing will be held in Room A of the Augusta Public Library, 823 Telfair Street Augusta, GA 30901.
