# SUMMARY

Staff became aware that Condition No. 1.b, "Revision Number," on pages 2 and 4 of Revision No. 7 of this certificate was erroneously left as Revision No. 6. Additionally, under "References," the May 6, 2013, reference has been corrected to May 7, 2013. Staff has corrected these errors and concludes that they do not affect the ability of the package to meet the requirements of 10 CFR Part 71.

### **EVALUATION**

Staff became aware of errors that had been made on Revision No. 7 of this certificate. In that revision, staff erroneously left the text under Condition No. 1.b, "Revision Number," as "6" instead of updating it to "7" on pages 2 and 4 of the certificate. In this revision, staff has updated the condition to "8." Additionally, staff erroneously dated a reference as "May 6, 2013" in Revision No. 7 when it should have been, "May 7, 2013." These changes correct a staff introduced error, and staff finds that the changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.

### CONDITIONS

Condition No. 1.b, "Revision Number," was updated to Revision 8.

The references section was updated to include the corrected date.

# CONCLUSION

The staff concludes that the changes indicated do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
