Dear Mr. Grohnert:

Enclosed is Amendment No. 06 to your NRC Material License No. 13-32721-01 in accordance with your request. Note that the major changes made to your license are printed in **bold** font.

Please review the enclosed license document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In your correspondence to us dated March 15, 2013, May 1, 2013, May 3, 2013, and May 21, 2013, you indicated that you wished to have approved a new interim storage area in a different part of the building specified in Condition No. 10. You also wished to release for unrestricted use your now-former storage area to permit renovations.

Amendment No. 05 authorized approval of the new interim storage area.

The NRC staff has reviewed your final status surveys, which consisted of removable contamination tests taken from your gauging devices in their DOT packaging.

Based on its review, the staff has concluded that all licensable radioactive material has been removed from your former storage area and residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for the former storage area and it is suitable for unrestricted use.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents.

The enclosed document contains sensitive security-related information.
When separated from this cover letter this letter is uncontrolled.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
