The NRC staff has reviewed the information provided in the DFS Report and determined that the following additional information is required in order to complete its review.

RAI #1: Amounts Accumulated

Please indicate if the amount of decommissioning funds identified in the report dated March 29, 2013, is for the after-tax amounts of decommissioning funds accumulated through December 31, 2012. If not, please provide the after-tax amounts of decommissioning funds accumulated through December 31, 2012, for PVNGS.

On March 29, 2013, APS reported the amounts of decommissioning funds accumulated as of December 31, 2012, for PVNGS, but did not indicate if the amounts stated were the before or after-tax balances.

The provisions of 10 CFR 50.75(f)(1) and (2) require the licensee to report the amount of funds accumulated to the end of the calendar year preceding the report.
