Dear Mr. Smith:

By letter dated January 28, 2013, (Agencywide Documents Access Management System [ADAMS] Accession No. ML13030A038), Honeywell International (Honeywell) provided the configuration changes, Integrated Safety Analysis (ISA) and safety demonstration report changes made to its Metropolis Works (MTW) facility during Calendar Year 2012, as required by its Material License Condition (LC) -20 (ADAMS Accession No. ML113260381). LC-20 was imposed by the U.S. Nuclear Regulatory Commission (NRC) via a letter dated May 11, 2007, (ADAMS Accession No. ML062140705). It requires Honeywell to submit all changes that affect the MTW ISA to the NRC for review within 30 days after the end of the calendar year in which the changes, either a revised ISA or revised ISA pages, as appropriate, were implemented.

The staff has reviewed the changes that Honeywell provided for Calendar Year 2012, and has no questions or comments at this time. The staff may re-evaluate the information Honeywell has provided if conditions at the facility change.
