## Good Morning Bob,

Please be aware that the requirement to name an RSO is a license condition. Not having a qualified individual named as RSO is a violation of that license condition (License Condition No. 11.B.). Since receiving notification that the former RSO has left the company, a licensing action has been opened to amend the license. Until you have made a final decision on a qualified individual to maintain responsibility of your radiation safety program, you will need to name a person who will be responsible for the management of the radiation safety program in the interim so that you will not be in violation. You may want to consider one of the authorized users currently named on the license. Also, please be aware that if there is not a qualified individual to assume the RSO or Authorized user responsibilities, work with radioactive materials may have to be suspended until such an individual is identified. Please submit a letter to us identifying the person who will be the interim RSO and assume responsibility for your radiation safety program until a permanent replacement is named. If you are ready to name a permanent replacement, please submit the name in addition to information demonstrating the person is qualified by training and experience commensurate with the types and quantities of materials being used. The letter must be signed by a member of your management and can be either faxed (610-337-5269) or can be emailed as a pdf attachment. In the letter please refer to Mail Control No. 581005.
