Pursuant to the Atomic Energy Act of 1954, as amended, the Energy Reorganization Act of 1974 (Public Law 93-438), and Title 10, Code of Federal Regulations, Chapter I, Parts 30, 31, 32, 33, 34, 35, 36, 39, 40, and 70, and in reliance on statements and representations heretofore made by the licensee, a license is hereby issued authorizing the licensee to receive, acquire, possess, and transfer byproduct, source, and special nuclear material designated below; to use such material for the purpose(s) and at the place(s) designated below; to deliver or transfer such material to persons authorized to receive it in accordance with the regulations of the applicable Part(s). This license shall be deemed to contain the conditions specified in Section 183 of the Atomic Energy Act of 1954, as amended, and is subject to all applicable rules, regulations, and orders of the Nuclear Regulatory Commission now or hereafter in effect and to any conditions specified below.

Pursuant to Sections 32.26, 10 CFR Part 32, "Specific Domestic Licenses to Manufacture or Transfer Certain Items Containing Byproduct Material," the licensee is authorized to distribute aerosol detectors in accordance with NRC Registration Numbers NR-1124-D-101-E and NR-1124-D-102-E containing sealed sources as specified in Condition 10 to person exempt from the requirements for a license pursuant to Section 30.20, 10 CFR Part 30, or equivalent provisions of the regulations of an Agreement State.

10. The following aerosol detector devices may be distributed pursuant to this license provided the amount of Carbon-14 contained in the devices does not exceed the amounts specified in the following table:


