Dear Ms. Jacobs:

On April 10, 2013, the U.S. Nuclear Regulatory Commission (NRC) received a letter from Mr. Chester Fugate, Licensing Manager, at Waterford Steam Electric Station, Unit 3, contesting NCV 05000382/2012404-02, "Failure to Make a Notification," which was documented in NRC Security Inspection Report 05000382/2012404, dated March 7, 2013.

On May 6, 2013, the NRC acknowledged Mr. Fugate's letter. We have completed our review and determined that the violation occurred as stated in the inspection report. The NCV will remain standing as stated in the inspection report. Details of the NRC review are attached.
