## 3) Transportation and Route Schedule

Sea freight on the Atlantic Cartier V. 3239. Vessel sails Hamburg, Germany on March 24, 2013. Due to the Port of Halifax, NS on April 8, 2013 and will unload. RSB will then pick up and cross the Canada/USA border at Lansdowne, ON/Alexandria Bay, NY or Woodstock, NB/Houlton, ME on/about April 13, 2013.
