This letter is in response to your application dated May 8, 2013 for amendments to your sealed source and device registration certificate No. NR-1267-D-102-E and the associated exempt-distribution materials license No. 04-24011-01E due to a change in the manufacturing and distribution locations. A review of your application indicated that it lacks required information to complete our safety review and evaluation. In the enclosure to this letter, we have summarized the issues that need to be addressed.

Please submit the requested information within thirty days of the date of this letter. If we have not received complete information within thirty days of the date of this letter, we will consider your application as having been abandoned by you. This is without prejudice to the submission of a complete application.
