Dear Mr. Giraudo:

The U.S. Nuclear Regulatory Commission (NRC) has determined that License SUA-1471 contains an administrative error made when Homestake Mining Company of California's (HMC) license, dated September 17, 1986, was issued by the NRC after jurisdiction over the license was relinquished by the State of New Mexico. License Condition 1 (LC1) to SUA-1471 identifies the licensee as Homestake Mining Company. On May 8, 1984, Homestake Mining Company officially changed its name to Homestake Mining Company of California. Therefore, the licensee name on the license is incorrectly stated. To correct this error, the NRC is issuing License Amendment 47 (enclosed) to revise the licensee name specified in LC1 to Homestake Mining Company of California. All other conditions of the license shall remain the same. An environmental review was not performed since this administrative action is categorically excluded under 10 CFR 51.22 ©(10).
