RE: Uranium One Request for Additional Information (RAI) response package for the Ludeman *IN SITU* Uranium Recovery Facility, Converse County, Wyoming – Docket No.: 04008502
Amendment Application to SUA 1341.

Dear Mr. Buckley:

Please find attached four CD's (two copies each) which contain responses to the NRC's request for additional information dated January 15, 2013 for the Ludeman Project Amendment Application to SUA -1341. One set of CD's contains responses and supporting documentation developed by Uranium One for the Application Technical Report and Environmental Report NRC RAI's. A second set of CD's contains responses to selected RAI's which are requested under 10 CFR 2.390 (b)(1)(ii) to be withheld from public disclosure. An affidavit to withhold this information is provided with this submittal.

As agreed upon with the NRC the format for this response package includes:

1. The original NRC RAI questions (Description of deficiency, Basis for Request and Formulation of RAI).
2. The Uranium One Response to each RAI including some or all of the items listed below:
 - A response to the RAI.
 - An insertion of the proposed change corresponding to a specific section of the TR or ER document that would address the RAI.
 - A supporting exhibit (Figure or Table) to address the RAI to be inserted into the final TR or ER.
 - A reference to an enclosed Appendix that contains information supporting a given RAI response that was longer and more complex or contained responses to multiple RAI questions. This submittal contains a total of five Appendices, two that support RAI responses for the Technical Report and three that support RAI responses for the Environmental Report.

There were five RAI's that Uranium One did not provide responses for. RAI's not addressed in the Technical Report included RAI's # 6, 7, 8 (Cross Sections) and RAI # 100 (Naming sands in the Leuenberger area), and RAI WR1 (revised Isopachs in the Leuenberger & Peterson area) in the Environmental Report. Uranium One is reevaluating the geology in select areas of the Leuenberger area as a function of obtaining new additional geologic drilling data. Uranium One anticipates submitting responses to these RAI's by early to mid July.


Modifications to some operational components of the Ludeman Project were discussed and presented to the NRC during the first quarter of 2013. These modifications were also evaluated in context to the RAI's and addressed when appropriate. However, one modification presented was the option to construct evaporation ponds to manage waste water (both 11e(2) and non 11e(2)) in addition to, or replacement of, deep disposal wells. Uranium One is currently developing the design package for the evaporation ponds option and will supplement the Amendment Application with this information in the near future. C. Basis for proposing the information withheld:


