This refers to your application dated June 18, 2013, for amendment of NRC exempt-distribution license no. 32-23858-01E. To enable us to complete our review, please provide a copy of your license from the State of Tennessee showing that you are authorized to possess and use radioactive material at the requested location.

In addition, please specify whether the Portland, Tennessee location will be in use before the Fresno, California is closed. If that is the case, we will issue an amendment to add the new location, and you will need to request an additional amendment to remove the old location when it has been closed.

Please submit the requested information within thirty days of the date of this letter. If we have not received complete information within thirty days of the date of this letter, we will consider your application as having been abandoned by you. This is without prejudice to the submission of a complete application with the required information.

In accordance with 10 CFR 2.390 of NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in NRC's Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
