<p>Summary:</p> <p>The licensee had questions about options for submitting amendment requests and the timeframe involved (including if there were options to expedite reviews). Shirley Xu told the licensee that:</p> <p>(1) the standard review period for amendments is approximately 90 calendar days,</p> <p>(2) amendment requests with multiple actions (e.g., one change-of-location request and one technical request) can be submitted separately so that one part of a request will not slow down the other part,</p> <p>(3) U.S. NRC personnel would email information about the criteria for expedited reviews to the licensee, and</p> <p>(4) U.S. NRC license reviewers are currently evaluating the letter dated March 28, 2013 (ML13115A031) from the Luxim Corporation. This letter notified the NRC that the parent company of the Luxim Corporation was to become JK Yaming International Holdings Pte. Ltd. on approximately March 29, 2013.</p> <p>Note: An email dated May 29, 2013 (ML13182A356) from Tony McGettigan (President and Chief Financial Officer of Luxim Corporation) to Margie Kotzalas names Peter Knapp as their consultant in NRC licensing matters.</p>
