This refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC) Office of Investigations (OI) to determine whether a radiation protection specialist at the Monticello Nuclear Generating Plant willfully failed to comply with the fatigue work hour rules. ### OI SYNOPSIS

This investigation was initiated on October 15, 2012, by the U.S. Nuclear Regulatory Commission, Office of Investigations, Region III, to determine whether a Radiation Protection (RP) Specialist at the Monticello Nuclear Generating Plant willfully failed to comply with the fatigue work hour rules at the site.

Based upon the evidence, this investigation did not substantiate the allegation that an RP Specialist willfully failed to comply with the fatigue work hour rules at the site.
