Pursuant to the Licensing Board's Memorandum and Order dated March 30, 2011, as modified by the Licensing Board's Notice dated September 12, 2012, the Staff is providing the Licensing Board and the parties an index identifying additions to the Hearing File required to be disclosed by the Staff pursuant to 10 C.F.R. § 2.336(d). Matthews, NRO (ADAMS Accession No. ML120740390), the Staff informed FPL that the Staff would reassess FPL's overall review schedule following the receipt of information requested in the May 4 letter. When the Staff sets new review schedules in light of the requested information, the Staff will promptly inform the Board and parties.
