This refers to your application dated February 26, 2013, for a sealed source and device registration certificate for a new device and the associated Application for Materials License, NRC Form 313, dated April 1, 2013. A review of your application indicated that it lacks required information to complete our safety review and evaluation. In the enclosure to this letter, we have summarized the issues that need to be addressed.

Please submit the requested information within thirty days of the date of this letter. If we have not received complete information within thirty days of the date of this letter, we will consider your application as having been abandoned by you. This is without prejudice to the submission of a complete application.
