Subject: Dresden Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan, Revision 12

In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) is submitting Revision 12 to the Dresden Station Security Plan. Changes to this Document were implemented on May 12, 2013. Based on feedback received, this is a re-submittal of revision 12 to the Dresden Station Security Plan.

The Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan has been revised to:

1. Include an RAI response from the Revision 11 submittal.
2. Adjust security staffing numbers based on site needs.

EGC has concluded that the changes do not decrease the safeguards effectiveness of the Dresden Security Plan, Training and Qualification Plan, or Safeguards Contingency Plan.

Attachments 1 and 2 contain safeguards information. Therefore, EGC requests that this information be withheld from public disclosure in accordance with 10 CFR 2.390, "Public inspections, exemptions, requests for withholding," paragraph (d)(1), and 10 CFR 73.22, "Protection of Safeguards Information: Specific Requirements," paragraph (a)(1)(i).


