SUBJECT: UNITED STATES DEPARTMENT OF AGRICULTURE, REQUEST FOR ADDITIONAL INFORMATION CONCERNING FINANCIAL ASSURANCE DOCUMENTS, CONTROL NO. 581317

Dear Mr. Jensen:

During a recent review of your license, it was determined that the financial assurance was deficient. In order to continue our review, we need the following additional information:

You currently have financial assurance under a certified value but you have a location in the Beltsville, Maryland area where you have submitted a decommissioning plan. In accordance with

10 CFR 30.35 (c)(6), the licensee must submit a decommissioning funding plan within one year of when the survey is completed. The surveys for this area were performed greater than one year ago. Please submit updated financial assurance that includes a Decommissioning Funding Plan.

This plan must include an actual estimate of the costs for decommissioning your facility and a description of the methods of assuring funds in accordance with 10 CFR 30.35(e). The appropriate level of detail for the cost estimate is discussed in Appendix A.3 to Volume 3 of NUREG-1757, "Consolidated NMSS Decommissioning Guidance." You may refer to your decommissioning plan which has already been submitted to the NRC. If the DFP cost estimate is greater than your current certification of financial assurance, you must submit a revised financial assurance instrument in the prescribed amount of the cost estimate. Please follow closely the recommended wording for financial assurance mechanisms found Appendix A to Volume 3 of NUREG-1757. Current funds for decommissioning the Beltsville facility should be described as having been obtained and committed and future funds can be described as that they will be obtained on a Statement of Intent. Financial assurance instrument must support the entire amount of decommissioning funding necessary.
