SUMMARY

This refers to your application dated April 4, 2013 for a new NRC license and the phone conversation between Jay Toney and Jennifer Bishop on May 14, 2013.

- In your application, you are named as the Radiation Safety Officer. However, you also state that you have not yet completed training. Please note that the NRC will not be able to issue your license without a qualified RSO. In addition, you will not be able to change and name your RSO internally; NRC must do that for you via the amendment process.
 - RESPONSE: Please include the name and qualifications of your proposed RSO and a written, signed (by both senior management and the proposed RSO) and a currently dated statement that stipulates your proposed RSO accepts the RSO position and understands the duties and responsibilities associated with the position. Each proposed RSO must be qualified in accordance with the guidance in NUREG 1556, Vol. 4 Section 8.7, Item 7: Individual(s) Responsible for Radiation Safety Program and Their Training and Experience. A sample Delegation of Authority memo is attached to this document in Attachment 1.
- 2. In Item 10, "Maintenance Routine Cleaning and Lubrication," you committed to using the gauge manufacturer or other authorized individuals to conduct non-routine maintenance. However, you did not indicate if you would be performing routine maintenance.
 - RESPONSE: Please respond by requesting either "We will implement and maintain procedures for routine maintenance of our gauges according to each manufacturer's recommendations and instructions" or provide the information in

Appendix N of NUREG 1556, Vol. 4 supporting the request to perform routine and non-routine maintenance in house.

3. Some of the devices that you have requested in your application do not require that you obtain an NRC License. Specifically, the Scan Technologies Model No. 2800 is distributed under a general license and the Thermo MeasureTech Model No. 5201 can either be obtained under a general license or a specific license. Please note that these devices can be on your specific license.

RESPONSE: Please indicate if you plan to obtain these devices using your specific license or using a general license.

4. In your application, you provided a copy of your Radiation Safety Program. Please note that if this document is included as a part of your application, you will not be able to make changes to it with requesting an amendment from the NRC.

RESPONSE: Please respond with a statement indicating if you would like this document excluded for you application.
