This is in response to your letter number 13-036, dated April 26, 2013, which submitted a revision to multiple sections of the Fundamental Nuclear Material Control Plan.

U.S. Nuclear Regulatory Commission (NRC) staff determined that the changes included in the updated Fundamental Nuclear Material Control Plan dated April 8, 2013, did not reduce the effectiveness of the approved safeguards program, were properly submitted under Title 10 of the *Code of Federal Regulations* (10 CFR) 70.32(c), and are therefore approved for use.

Materials License SNM-42 will be amended at a later date revising Safeguards Condition 5.1 to include the April 8, 2013, revision date. All other conditions of this license shall remain the same.

Technical Assignment Control Number L33277 is closed.
