On June 27, 2013, the U.S. Nuclear Regulatory Commission (NRC) completed an inspection of the control and accounting program of Special Nuclear Material (SNM) at your Oconee Nuclear Station Units 1, 2, and 3. The enclosed inspection report documents the inspection results which were discussed on June 27, 2013, with Mr. Terry Patterson and members of your staff.

The inspection examined activities conducted under your licenses as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your licenses. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel. Based on the results of this inspection, no findings of significance were identified.
