Jennifer and Steve,

I am hoping that although Amendment 11 is making its way through the Rulemaking process, an obvious, small change can be made to the Tech Spec (TS) definition for TRANSFER OPERATIONS. The attached 5-page pdf shows the situation. I expound a bit below on each page.

Page 1 – Amendment 13 TS page which correctly indicates ‘DSC’ and not ‘TC’  
Page 2 – The Amendment 13 submittal page which explained why ‘TC’ needed to change to ‘DSC’  
Page 3 – The Amendment 11 TS page which still shows ‘TC’  
Page 4 – The CoC 1029 Standardized Advanced NUHOMS TS page from the current TS, showing ‘DSC’  
Page 5 – The CoC 1030 HUHOMS HD TS page from the current TS, showing (32PTH) ‘DSC’

The need for the change to the Amendment 11 TS is obvious, I believe. Would you please advise whether you believe you will be able to make the change without impacting the schedule?
