By letter dated April 10, 2013 (from Mr. William Gideon), Carolina Power & Light (CP&L), doing business as Progress Energy, submitted a request to the U.S. Nuclear Regulatory Commission (NRC), in accordance with 10 CFR 72.56, for an amendment to Materials License No. SNM-2502 for the H.B. Robinson Steam Electric Plant Independent Spent Fuel Storage Installation (ML13114A057). The requested amendment would change the corporate name of the licensee from Carolina Power & Light to Duke Energy Progress.
