SUBJECT: SUMMARY OF THE JULY 11, 2013, CATEGORY 2 MEETING

REGARDING NATIONAL FIRE PROTECTION ASSOCIATION

STANDARD 805: NUCLEAR REGULATORY COMMISSION/NUCLEAR

ENERGY INSTITUTE MANAGEMENT DISCUSSION

On July 11, 2013, the U.S. Nuclear Regulatory Commission (NRC) Division of Risk Assessment (DRA) management held a meeting with Nuclear Energy Institute (NEI) management to discuss questions requiring management attention related to National Fire Protection Association Standard 805 (NFPA 805).

The participants discussed, at a high level, the following topics:

- Discussion of issues related to the license amendment request (LAR) reviews and safety evaluation issuance
 - > DRA management stated that the NRC staff was working hard to meet the schedules for the first four non-pilot safety evaluations.
 - > NEI representatives asked whether the LAR reviews would be affected by the current federal budget situation, and if any of the schedules would change.
 - DRA management stated that the NFPA 805 reviews continue to be a high priority for the NRC.
 - DRA management stated that possible efficiencies continue to be explored.
 - DRA management stated that any schedule changes would be discussed on a caseby-case basis with individual licensees.
 - ➤ NEI representatives asked whether future NFPA 805 license conditions would require NRC approval for fire probabilistic risk assessment changes (Fire PRA).
 - DRA management stated that the pilot plants received similar license conditions.
 - DRA management further stated that similar license conditions are not preferred, but would be used if needed.
 - NRC staff stated that the goal of such a license condition is to be able to approve a self-approval process for the licensee, by ensuring the fire PRA is of sufficient quality.
