- Agenda Items*:**
1. The NRC staff has questions regarding the reference document is NRC3-13-0019, licensing basis SSI analysis of RB/FB and CB. Documented dated 6/4/2013 on Fermi docket.
 - i. The report identified some spikes in the transfer functions (Figures 3.5-12, 15, 33, and 46) and indicated that these are isolated and does not have any impact on the results. While this may be the case, the report should clarify as to why they occur.
 - ii. For several instances transfer functions for the RSW top node and the RPV Top node appear to show that there is significant coupling in the X-Direction due to excitation in the vertical Z-Direction (Figures 3.5-15, 18, 33, 36, 51, and 54). However, this strong coupling is not exhibited in the other horizontal direction. We need further explanation on what is the reason for this behavior?
 2. DTE has requested to discuss their revised RAI response about moving Cf-252 in the FSAR. Their approach is a little different than previously discussed. – Related to Chapter 1 Part 30
