COMMISSION STAFF LEGAL DETERMINATION REGARDING PRESENCE

OF 11e.(2) BYPRODUCT MATERIAL IN THE HIGHLAND PIT LAKE

Dear Mr. Zuschek:

By letter dated February 11, 2013 (ML13105A059), ExxonMobil requested that the U.S. Nuclear Regulatory Commission (NRC) staff make a final legal determination that the Pit Lake at the Highland uranium mill tailings facility, in the State of Wyoming, contains 11e.(2) byproduct material as defined under Section 11(e) of the Atomic Energy Act of 1954, as amended.

The NRC staff has reviewed your request and determined that it is duplicative of a license amendment request (ML11136A199), dated May 12, 2011, that is currently being reviewed by the NRC staff. As part of its 2011 license amendment request, ExxonMobil proposed that the Pit Lake be included within the long-term surveillance and monitoring boundary for the site as ExxonMobil believes that the Lake contains 11e.(2) byproduct material. The staff anticipates that it will make the necessary determination as to the appropriate classification of the radioactive material in the Pit Lake and its disposition within the context of the license amendment request currently under consideration.
