The Pactiv Packaging (Pactiv) Mineral Wells, WV facility operates thickness gauges containing radioactive sources under NRC's General License, and has been assigned General License Registration No. 713575-16. Pactiv recently removed two (2) of these gauges/devices from the facility, and is notifying the NRC of the off-site transfer/disposal of the removed gauges/devices within 30 days of transfer, as required by 10 CFR 31.5.

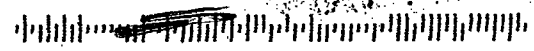
