Mobile nuclear medicine to temporary job sites.

1. The mobile van will have a Digirad portable gamma camera.
2. All deliveries that are made to the vans will have a technologist there to receive the packages
3. Only recalibrated unit does will be used.
4. Either a digital survey meter with a scintillation probe or a well counter will be used for assaying both the packages wipes and the site area wipes as required.
5. The vans will be locked and secure when there is no one on board.
6. All required quality control for the gamma camera and the counting equipment will be performed.
7. Training will be provided for both the technologist and ancillary personnel.
8. All Dot rules as listed in 10CFR49 will be followed. The van will contain all required document.

9. Communication with the RSO is by cell phone with response within two hours maximum. The RSO (or a representative) can be on site within 24 hours if required.

10. Copies of the client site diagram and Memorandum of Understanding (MOU) will be kept on file for inspection at the base site. Along with all required records.

11. The base of operations is the main office.

12. All radioactive waste will be transported to the base site for decay or disposal. All used and unused unit will be returned to the radiopharmacy for disposal.
