**INPO BOARD ELECTS LYNN GOOD AS DIRECTOR**

The Board of Directors of the Institute of Nuclear Power Operations (INPO) elected Lynn Good, president and chief executive officer of Duke Energy, to the INPO Board effective July 18, 2013.

Good became president and chief executive officer of Duke Energy on July 1, 2013. Prior to assuming her current role, she served as executive vice president and chief financial officer. Having served as Duke Energy's CFO since July 2009, Good continued in that role following the company's merger with Progress Energy in July 2012. Before the Duke Energy/Cinergy merger in April 2006, Good served as executive vice president and chief financial officer for Cinergy.

Duke Energy has operated nuclear power plants for more than 40 years. These include – Brunswick Nuclear Plant, McGuire Nuclear Station, and Shearon Harris Nuclear Plant in North Carolina; Catawba Nuclear Station, Oconee Nuclear Station, and H. B. Robinson Nuclear Plant in South Carolina.

The INPO Board includes INPO's chief executive officer plus executives elected from INPO's membership, which encompasses all U.S. commercial nuclear operating organizations.

INPO is a nonprofit corporation established by the nuclear utility industry to promote the highest levels of safety and reliability – to promote excellence – in the operation of commercial nuclear power plants.
