SUMMARY OF JULY 10, 2013, TELECONFERENCE WITH HOLTEC INTERNATIONAL – ANALYSIS REVIEW OF HOLTEC MODEL 100 AIR FLOW ANALYSIS			
SUMMARY			
A teleconference was held on July 10, 2013, in Rockville, Maryland, between U.S. Nuclear Regulatory Commission (NRC) staff and Holtec International Technical Staff (Holtec). The purpose of the teleconference was to obtain information to assist NRC staff in making a determination regarding additional actions, Brief discussion provided by Jimmy Chang to refresh all teleconference participants on the need by NRC to review Model data. Response from Holtec's Technical Staff representative indicated that the model data had not been sent because ANO needed to check the calibration on some equipment used during an NRC inspection and the accuracy of the calibration checks were valuable to the Holtec in ensuring that model data was still representative of the proper conditions that occurred during the inspection. Holtec indicated that sending the model data prior to ensuring the calibration integrity may have been premature and required a re-review by NRC to any corrections that may have been determined necessary due to calibration errors. Both NRC and Holtec indicated that waiting for the calibration check to occur was best so that NRC would be provided the most accurate model information for review.
