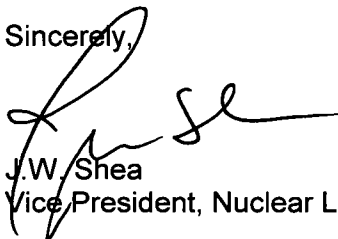
Subject: Response to NRC Regulatory Issue Summary 2013-06, Preparation and Scheduling of Operator Licensing Examinations
