SUBJECT: BOILING WATER REACTOR (BWR) OWNER'S GROUP (BWROG) REQUEST  
FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE

Dear Mr. Schiffley:

By letter dated June 6, 2013, an affidavit dated June 6, 2013, was executed and submitted by Mr. Harry A. Goodman, BWROG Vice Chairman, requesting that the information contained in Enclosure 1 to Mr. Goodman's letter be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR), Part 2, Section 2.390. Enclosure 1 is titled as follows:

Report BWROG-TA08-001, "Damage Pressure and Zone of Influence for BWR Coatings."

A nonproprietary copy of this document has been placed in the Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the Agencywide Documents Access and Management System Electronic Library.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure because it is:

- a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by BWROG's competitors without license from BWROG constitutes a competitive economic advantage over other companies;
- b. Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.

Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
