Dear Mr. Capps:

Enclosed is a copy of the Dam Safety Inspection Report for Standby Nuclear Service Water Pond (SNSWP) Dam prepared by the Federal Energy Regulatory Commission (FERC) for the U.S. Nuclear Regulatory Commission. The enclosure contains the results of an inspection on April 17, 2013, on the SNSWP Dam at McGuire Nuclear Station, Units 1 and 2. The earth dam, outlet structure, toe area, abutments, instrumentation and topographic features around the SNSWP were inspected. During this inspection, no conditions were found that should adversely affect the immediate safety, permanence, and operational reliability of the reservoir or present a threat to the safety of the public or the nuclear facility. The SNSWP dam and appurtenant structures appeared to be in satisfactory condition and adequately maintained.

At FERC's request, the enclosure is not being made publicly available since it contains critical energy infrastructure information.

**The enclosure transmitted herewith contains Security-Related information. When separated from the enclosure, this document is decontrolled.**


