Radioactive Materials Licensing:

Cardinal Health 414, LLC (Nuclear Pharmacy Services, hereafter Cardinal Health) hereby notifies the NRC of our intent to cease the primary function as a pharmacy for distribution of radioactive material for the location at 2131 E. 32<sup>nd</sup> Street, Suite 1, Joplin, Missouri and begin decommissioning. A subsequent request for release for unconditional use of the restricted area will follow under separate cover.

The above referenced location will cease to operate as a nuclear pharmacy effective August 2, 2013. Surveys and documentation of the disposition of radioactive materials will be provided following the removal of all sources of radiation and radioactive waste during a decay period of less than 90 days.
