Dear Mr. Stamper:

Enclosed is Amendment No. 29 to your NRC Material License No. 21-14894-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please note that your response to item 5 was not adequate in that it did not address whether you would like to remove the Troxler Model No. 3241 gauge. Therefore, the Troxler Model No. 3241 gauge will remain on your license. If this gauge should be removed from the license, please submit a request to remove any models and provide the documentation showing these devices have been properly transferred. In addition, the NRC staff has reviewed the information provided and based on its review; the staff has concluded that all licensable radioactive material has been removed from your facility located at 480 Ford Field, 2000 Brush Street, Detroit, Michigan. Therefore, we have authorized the release of this location for unrestricted use.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. 
