SUBJECT: Results of Periodic Review of Regulatory Guide (RG) 1.132

This is to document the agency's periodic review of RG 1.132 "Site Investigation for Foundations of Soils and Rocks for Engineering Analysis and Design of Nuclear Power Plants." As discussed in Management Directive 6.6 "Regulatory Guides," the NRC staff reviews regulatory guides approximately every five years to ensure that the guides continue to provide useful guidance.
